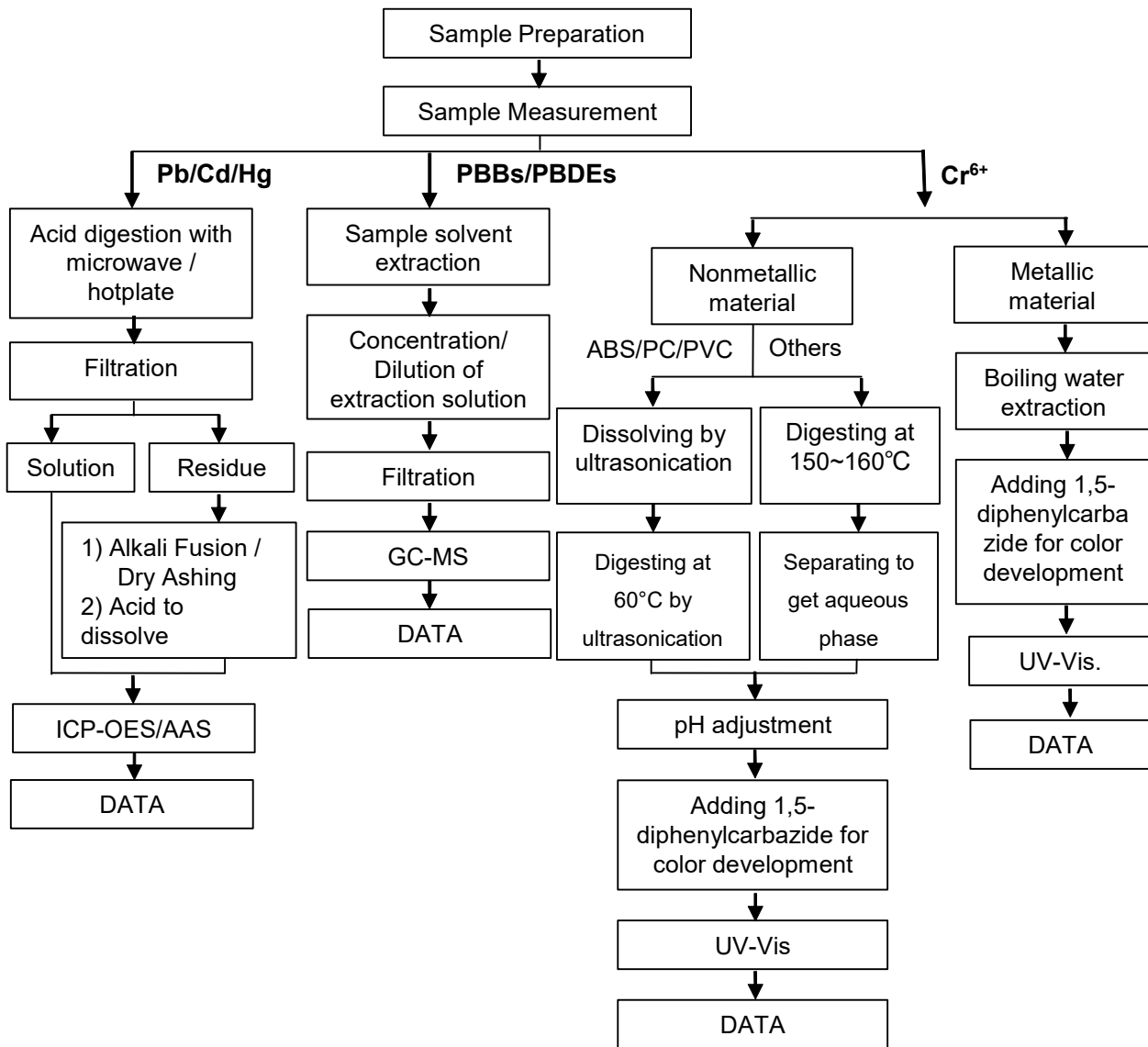

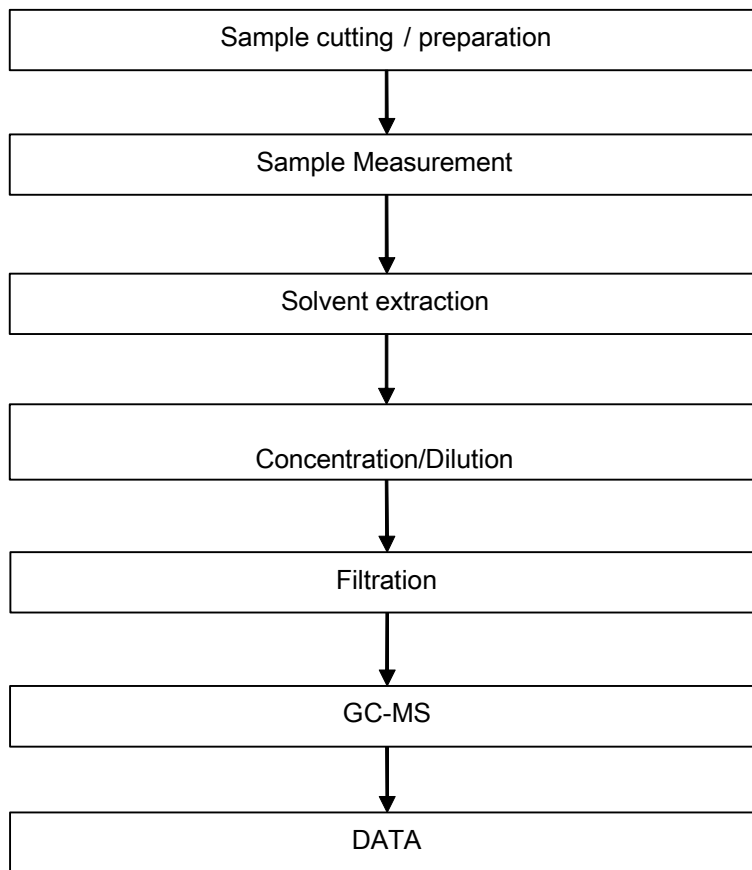

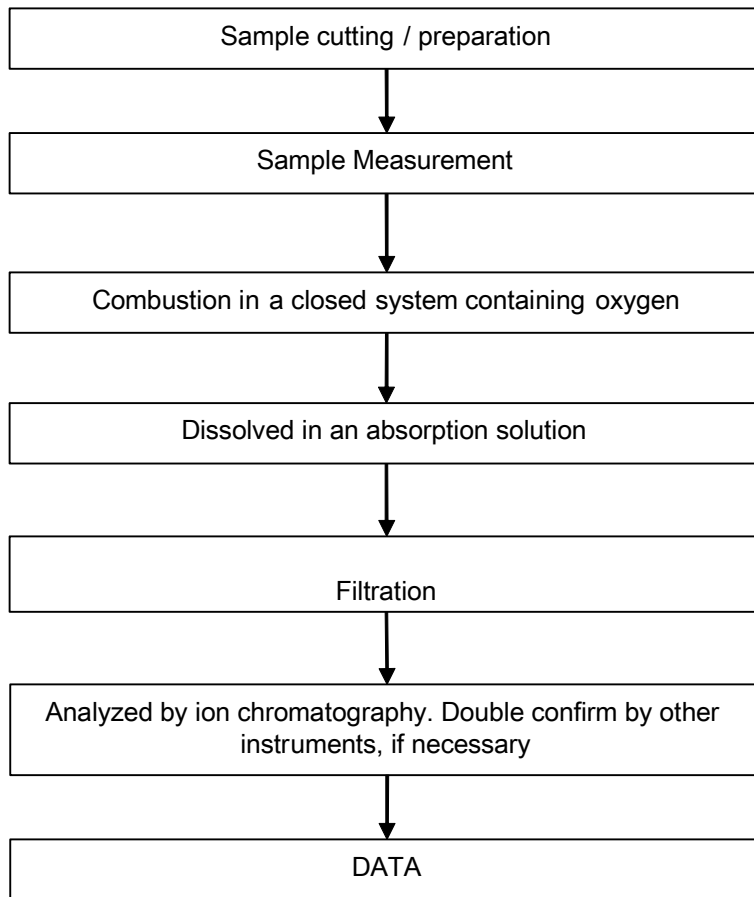
### Phthalates Testing Flow Chart

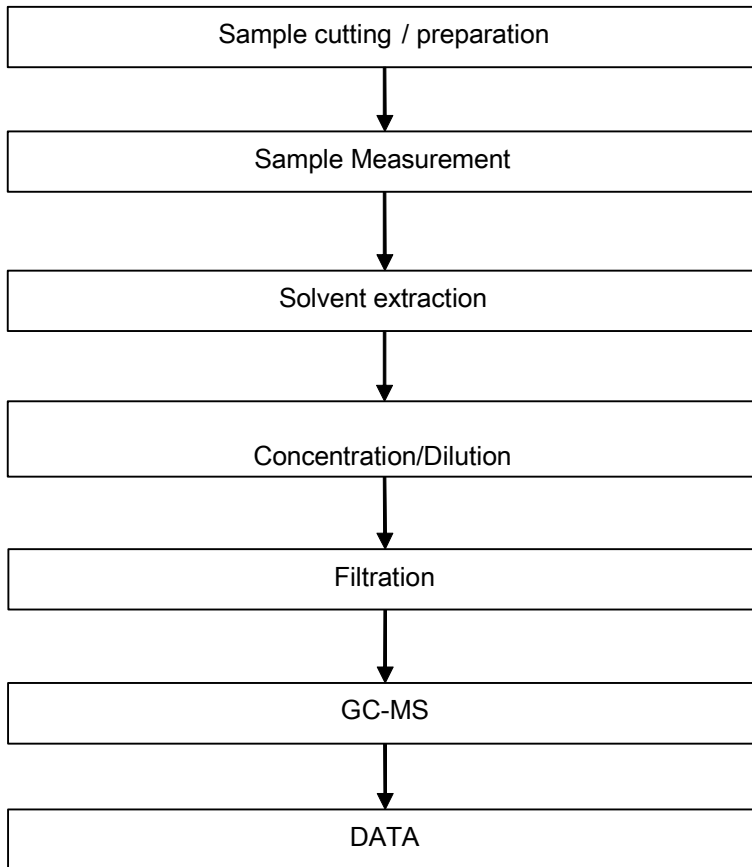

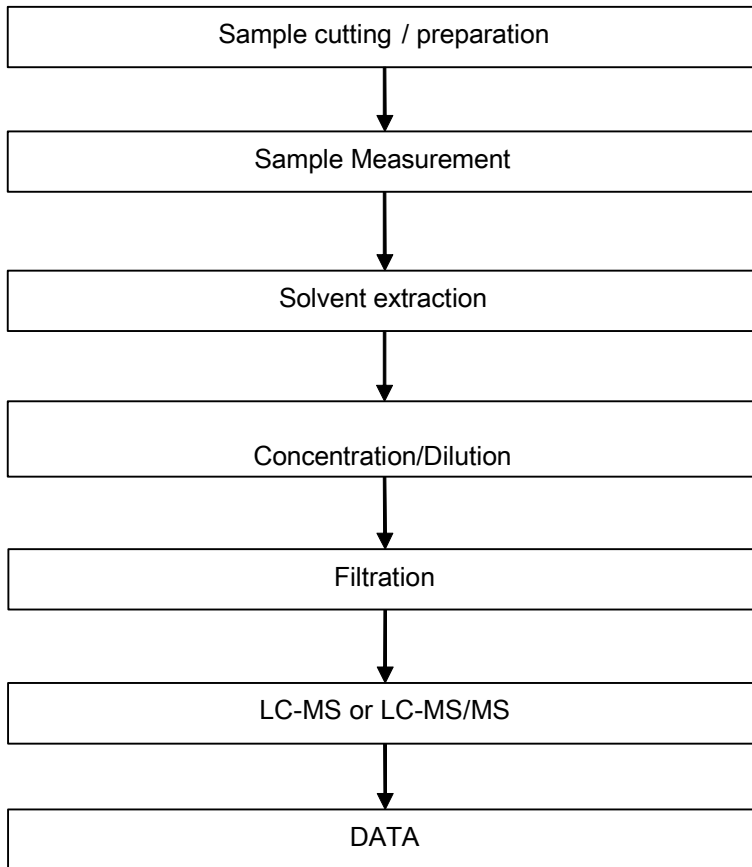
### PAHs Testing Flow Chart

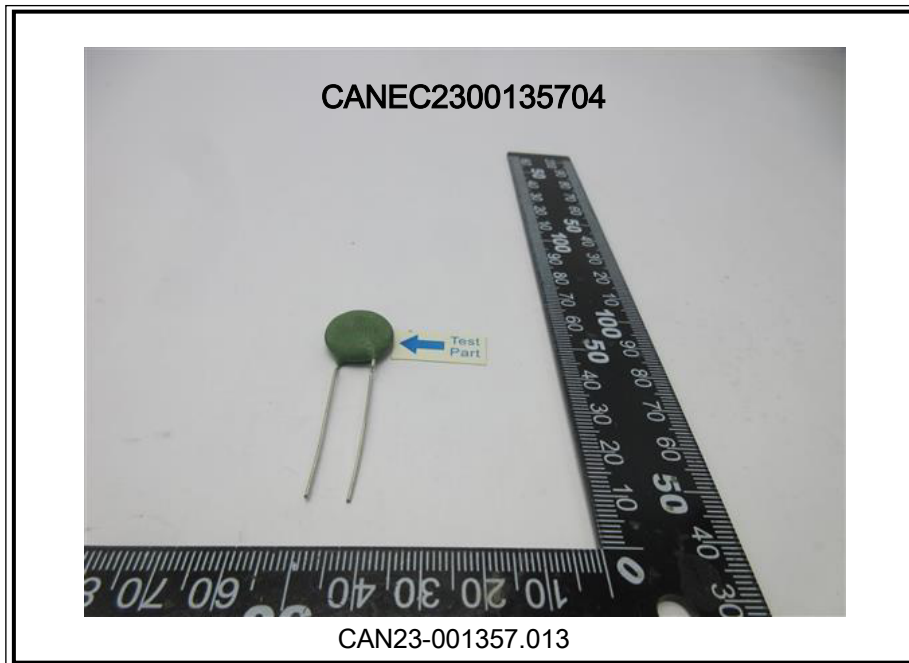
### Testing Flow Chart
