



Hexavalent Chromium (Cr(VI)) Testing Flow Chart



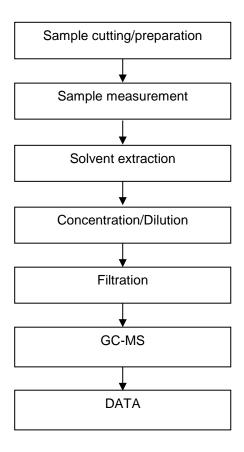



PAHs Testing Flow Chart





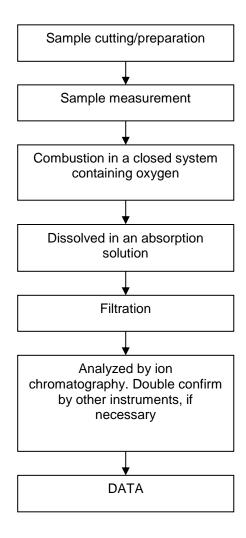

Halogen Testing Flow Chart





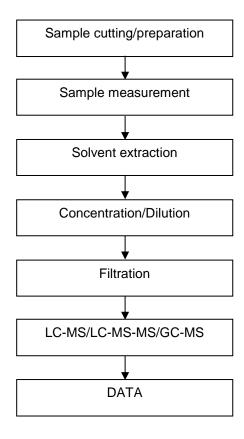
