





PBB/PBDE/Phthalates Testing Flow Chart





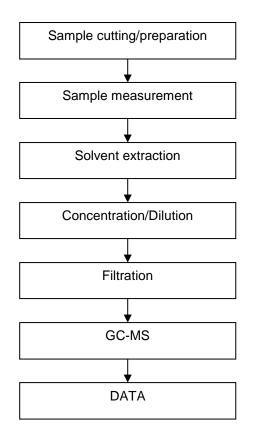



Halogen Testing Flow Chart







PFASs/ PFOS/PFOA Testing Flow Chart




